



## **Axford Policy Research Topics – Learning from the United States**

### **For Fellows in New Zealand 2026**

The Ian Axford Fellowships in Public Policy are for outstanding mid-career US professionals to bring their expertise in public policy to a New Zealand government agency.

The Fellowship is interested in candidates who can contribute to contemporary policy priorities in New Zealand. Below you will find examples of some of the past questions that Fellows have answered for New Zealand, as well as prompts depicting a number of questions that have been identified as being particularly useful for future Fellows to explore. This list is not exhaustive and we encourage applicants working in areas not listed below, who think their area of expertise would be useful to New Zealand public policy, to also consider applying.

At the end of this document, you will find a list of resources to further help you navigate priorities of the New Zealand government and better understand its organisation.

Where possible, the Ian Axford Fellowship will assist you in identifying a relevant individual at your proposed host agency to discuss your potential project. Please note that identifying a relevant contact can be lengthy, and therefore we recommend you begin this process at least three weeks prior to the application deadline to avoid disappointment. ***Unfortunately, the Ian Axford Fellowship is unable to guarantee assistance in finding a relevant contact at every agency.***

## **Key questions to prompt further exploration of possible topics**

### Emerging Technologies

- How might we harness the benefits of AI and other new technologies to improve public services and outcomes for New Zealanders?

### Energy and infrastructure

- What are our future energy and infrastructure needs, and what are some creative ways of addressing these?
- How can we best prepare for future national and regional emergencies, and how should we manage responses when they occur?

### Economic growth

- How can we harness new ways of working to drive economic growth?
- How can we ensure that regulation promotes growth and economic efficiency in New Zealand's key industries (eg agriculture)?
- How can price stability be secured in the New Zealand economy?
- What ways can we prepare more New Zealanders for the workforce?
- How can we improve competition in key sectors (eg banking and the grocery sector)?

### Society and social issues

- How is society changing, and how might our democratic and policy processes need to change in response?
- How might government institutions, agencies and thinking adapt to respond to modern challenges?
- How can we work differently, across government, private and community sectors to solve some of our most difficult social issues (eg, family violence, housing insecurity)?
- How can we reduce crime (including youth re-offending and organised crime)?
- What ways can we improve outcomes for school students (eg, attendance and maths/literacy attainment)?
